MESSAGE FROM OUR PRESIDENT - ARTHUR GRIFFITHS

"A hearty "thank you" to our membership! My request for aid in the last newsletter was met with a generous response and I was delighted to annouce at our Annual Meeting that the Upton cabin on Middle Carry Pond was ours - paid in full!

I am also pleased to report that the Crosby Milliman's, both long-time members of A.E.H.S. and key participants in AEQ-',75, are in residence at the Colburn House. Cros and Karen moved to Pittston from Canada just prior to the annual meeting and the members attending were treated to a tour of the premises furnished with period furnishings from the Milliman's own collection. The ell of the house has been renovated into a comfortable apartment for our curator-in-residence and Cros told the members that their house is open to inspection 365 days a year. Restoration of the house will continue as funds become available. The apartment was completed under the direction of Cecil Pierce, who guided the project through to completion on a shoestring budget and with Yankee ingenuity.

We secured a grant from CETA which provided the services of two carpenters who are available to us until March of 1980. With the completion of the apartment, they are working on the barn - museum, installing a second floor meeting room for the Society. This project will be completed during warm weather since no plans for heating this addition are contemplated.

However, with the onset of cold weather, we hope to raise funding for materials to permit them to work inside the Colburn House. We would like to restore the "keeping room" and boatyard office which was an important part of the house when Major Colburn occupied the premises in 1765.

Since the Society's meager funds have been husbanded to best use on the projects completed to date, the state of the Treasury is gravely depleted.

We need:

- 1. Prompt dues payments from our loyal members (which are payable as of July 1st.)
- 2. More loyal members to pay dues promptly, as well as additional members.
- 3. Additional contributions to provide materials for our restoration project.

Let me reemphasize that we are CETA funded through March for all our labor costs, and you all know how much those labor costs could be if we had to raise the money. We have the labor. We need only to secure the materials.

It seems to be the lot of all presidents of non-profit organizations to be on the constant search for funds to complete the vital programs so necessary for the meaningful growth of a society such as ours. So, here I am, hat in hand, knocking on the door and looking for more help.

Prior to the June meeting, my mind traversed the brief span of time since White Nichols and a tiny group of colonial history buffs met at the now demolished Augusta House and founded A.E.H.S. What amazing progress has been made since that day! We have acquired for all time a part of the Arnold Trail through some of Maine's most beautiful wilderness, and we have demonstrated our zeal for preserving that wilderness for those generations yet to come.

We staged a Bicentennial Reenactment on an international scale involving participants representing a broad geographical area. We were among the first of the Bicentennial events in the nation. We had no precedent to emulate save that of Arnold's men as recorded in their journals, yet we gave the nation a birthday example second to none.

We acquired the Colburn House as a State and national historic site, not only for the significance of its role in providing the Arnold bateaux, but also for its role as a key point in the development of colonial America. In my opinion it is essential to preserve certain relics of our heritage as reminders to our children of the dedication and effort that went into the heritage with which they are so fortunately blessed. If we remember the past, perhaps we can shape the future with the wisdom that must be exercised to overcome the complex problems with which we are faced. And what better way to remember the past than to maintain select reminders? This is our small contribution to the future generations yet unborn - whose memories will best be shaped if they can experience at first hand a tidbit of their inheritance as it once was.

Indeed, A.E.H.S. has come a long way in a short time. In our own small way we have made significant and lasting contributions for the general well-being of our fellows. With your continued aid and support we will proceed on the course we have chartered. "

Introducing Sumner A. Webber of Coopers Mills, Maine, a director of Arnold Expedition Historical Society.


Sumner is the son of Marvelle C. and Emeroy (Kinsman) Webber and was born in Rutland, Vermont, June 27,1936. He attended the elementary school in Hallowell, Maine and the Millbrook High School in Millbrook, N.Y. He is a graduate of Middlebury College in Middlebory, Vermont. He served as a Captain the U.S. Army 1961-64.

Since 1963, Sumner has been a teacher at the Hall-Dale High School in Hallowell, Maine (speech and social studies).

He married Catherine McConnell in Bangor, Maine, in 1964 and they have two children - Sarah, age 13, and Sumner, Jr., age 8.

Summer served as chairman of the Whitefield School Board for two years. He is a member of the Maine Archaelogical Society. His hobbies include gardening restoring a circa 1810 (Cane

In the 1975 Reenactmant of the Arnold Expedition to Quebec (AEQ-'75), sponsored by the Arnold Expedition Historical Society, Summer portrayed Captain James Howard, the first and only commander of Ft. Western. In 1775 Arnold's Army stopped at Ft. Western and in 1975 during our country's Bicentennial Celebration "Arnold's men stopped at Ft. Western where Captain Howard invited Arnold to establish his office in the meeting room of the fort, repeating the invitation extended 200 years ago."

A history major at college, Sumner's knowledge and experience make him not only highly qualified as the curator of Ft. Western, but those same qualifications and his willingness to serve, in spite of his heavy schedule, stand the Arnold Expedition Historical Society in good stead to have him a member of our Board of Directors.

The weather held passing fair for our annual meeting held on the Colburn House lawn on Saturday, June 30th, 1979 at 1:30 p.m.

Arthur Griffiths, President, greeted the members and his message, recorded above, covers the highlights of his comments and announcements.

Cecil Pierce, Chairman of the Nominating Committee, presented a slate of officers for the ensuing year and replacement of directors whose 3-year terms had expired. The following were unanimously voted as elected:
